


Who we are

2018/19 Key Highlights



2018/19 has been a year of stabilisation and we have focused on:

- Improved Quality of Care
- Strengthening governance arrangements, Ward to Board
- Stabilising the Leadership Teams
- Developing organisational culture
- Improved system relationships





Quality of Care



- We have improved compliance across a range of quality and performance indicators such as:
 - Venous thromboembolism (VTE) 96.6%
 - Management of Serious Incidents less than 4 per month
 - Duty of Candour 100%
 - Combined Harms Reviews 96.6%
 - Complaints 100%
 - 18 week Referral to Treatment (incomplete pathways) 80% by 31.3.19
 - 52 week Referral to Treatment 0 by 31.3.19
- Developed a Ward Accreditation process: Wirral, Individual, Safe Care, Every time





Leadership



- Stabilised the Board of Directors and Senior Leadership teams
- Clinically led organisation
- Introduced:
 - Top leaders programme for bands 7 and above
 - Leadership masterclasses



Accounts headlines










Income and gains: £353.2m

Total income/gains were

- £16.5m above plan;
- £16.2m (5%) higher than in 2017/18.

Of this total, £307.9m (87%) was NHS clinical income.

The Trust received no Public Sector Finance (PSF) income in 2018/19.










Expenditure: £390.7m

Total expenditure was

- £28.8m above plan;
- £36.4m (10%) higher than in 2017/18.

£253.5m (65%) of expenditure related to pay, which was £5.6m higher than planned. £4.1m of this variance related to pay reform, which was centrally funded.









Capital programme 2018/19

- £2.6m Digital Wirral investment in the Trust's patient care systems funded by the DHSC's Global Digital Exemplar (GDE) programme.
- £3.2m Improvements to the Trust's built estate including work to increase capacity over a number of wards.

- £4.3m Medical equipment and facilities improvements, including
 - £1.5m MRI scanner; and £0.5m refurbished X-ray rooms.


 £1.4m Information technology improvement schemes and a replacement telephony switchboard.

















Other key measures

- Financial Use of Resources Rating dropped from 3 to 4.
- 2.7% Cost Improvement Programme (CIP) was delivered, representing a shortfall of £1.4m against the challenging £11.0m target.
- WUTH continues to be a 'going concern'.
- Value for money conclusion was qualified ('except for').
- Financial accounts audits were 'clean' no issues identified, but there was a national technical matter highlighted relating to the Trust's valuers.
- No financial internal control deficiencies identified.









During 2019/20, the Trust will continue on its journey towards financial sustainability, dependent on the following factors.

- System-wide collaboration and solutions.
- Close management of costs, delivering activity plans within agreed budgets.
- Development and delivery of ambitious, transformational CIP schemes.
- Continued access to support funding (loans) from the Department of Health and Social Care.
